**NOTE:**

1. The eligibility criteria for each post as defined in **ANNEXURE-I** and the aspiring applicants satisfying the eligibility criteria in all respect can submit their application.
2. Application form is attached to this notification as **ANNEXURE-II**.
3. If suitable candidate is not available for the mentioned post of Professor & Associate Professor it will be operated at lower level as Additional Professor & Assistant Professor respectively as per respective cadre category. **Separate applications to be submitted by the candidates who want to apply for the post which may be operated in lower cadre.**
4. The number of posts & category mentioned above may vary.
5. All other category candidates can apply against the posts earmarked for UR Category and their candidature will be considered as UR category **only** viz., there shall be no relaxations which are otherwise permitted under their specific categories as per Government of India, DoPT O.M No. 36011/1/98-Estt.(Res) dated 01.07.1998.
6. Age relaxation will be given to SC/ST/OBC/ PWD/ Ex-Serviceman candidates if they have applied under such category and Government Servants In-service (Central Civil Employees only) as per G.O.I rules.
7. No change in the reservation category applied shall be permitted once the registration fee is submitted. If incorrect information is found at any stage of the recruitment process, the candidature shall be cancelled.
8. All other category candidates can provisionally apply against post earmarked for EWS Category with the following conditions:
  - i. That their candidature will be considered only if, suitable EWS candidates are not available.
  - ii. That their candidature will be considered as UR category only, viz., there shall be no relaxations which are otherwise permitted under their specific categories.
9. Selection will be subject to document verification made through statutory committee. NIMHANS reserves the right to cancel, change clause, not to appoint any post including change in posts and its vacancy.
10. **4% Reservation for PwBD Candidates as per Government of India Reservation Policy from among the above Notified posts.**
11. The upper age limit in respect of Scheduled Castes, Scheduled Tribes, Ex-Servicemen and other special categories of persons etc. shall be relaxable in accordance with the orders issued by the Government of India from time to time. All candidates are advised to obtain required valid category certificate in advance to avoid cancellation of candidature at any stage of the recruitment process. For claiming the benefit of age relaxation, they shall invariably submit, the requisite certificate from the Competent Authority and also submit a declaration as and when called for by NIMHANS, otherwise their claims for age-relaxation shall not be considered.
12. The validity of the OBC (Non-Creamy Layer) certificate issued in the Central Government format (digital with QR code) for the financial year **2025–2026** shall be considered only if the certificate is issued between 01.04.2025 and the last date of submission of the application (**ANNEXURE-III**).
13. The EWS certificate issued in digital form with QR code for employment under the Central Government, based on income for the financial year **2025-2026**, shall be considered valid only if it is issued between 01.04.2025 and the last date of submission of the application (**ANNEXURE-IV**).
14. A No Objection Certificate (NOC) issued by the present employer (**ANNEXURE-V**) must be uploaded while filling the application form in respect of candidates working in Government / Semi-Government / Quasi-Government / PSUs / Autonomous Bodies or any institution funded by the Government. Failing which, the candidature shall not be considered for any post. Therefore, candidates are advised to obtain

the NOC before applying. Further, it is mandatory to produce the original NOC at the time of document verification & Personal Interview. Candidates working as contractual employees in Government / Semi-Government / PSUs / Projects / Autonomous Bodies or any institution funded by the Government are also required to produce the NOC mandatorily.

15. Any corrigendum / addendum / modification, etc. In the notification will be made available on the Institute's website only.
16. The application processing fee as stated below shall be paid through State Bank of India "SB Collect PAYMENT" link available in this Institute Website <http://www.nimhans.ac.in> and the detailed instructions for making payment is listed in the **ANNEXURE-VI. The PwBD Candidates are exempted from the payment of application / processing fee.**

17. The details of the application processing fee paid, along with the transaction details, must be compulsorily filled in **ANNEXURE-VII** provided. Applications with incomplete details shall be rejected.
18. It is mandatory for the applicant to enclose self-attested copies of certificates of Age Proof, Academic Qualifications, Marks Sheets of all the years / semesters, Experience, etc., No applications shall be entertained if it is incomplete / received after the last date prescribed / not forwarded through proper channel. The Institute will not take responsibility for postal delay if any.
19. No separate intimation / communication will be sent to candidates who are not Eligible.
20. In case if it is felt necessary, the Institute may not fill up any or all the above posts and if so, no separate intimation will be given to the candidates.
21. The reserve list against future vacancies will be operated for 01 year from the date of personal interview.
22. **The number of vacancies / category-wise vacancies may vary or likely to change.**
23. The application format should not be altered. Any additional information may be enclosed as a separate Annexure.
24. All the enclosures should be **neatly tagged to the application.**
25. The Candidate should not have been convicted by any Court of Law.
26. All disputes will be subject to jurisdiction of Court of Law at Bengaluru.
27. The application in the prescribed form shall be submitted along with the PUBMED Index details **(ANNEXURE-VIII)** and the transaction/payment details for having remitted the prescribed application processing fee, as stated above.
