Note for Deputation Posts

- 1) Maximum age limit for applying for the aforesaid posts on Deputation is 55 years as on last date of receipt of application.

- 3) **Application from Non-government employee will not be entertained.**
- 4) Incomplete applications received without the above-mentioned documents and applications received after the due date will be summarily rejected.
- 5) Supporting documents related to experience etc. have to be self-attested.
- 6) NIMHANS, Bengaluru strictly adheres to the Recruitment Rules as notified in this Notification.
- 7) The Institute will not be responsible for any postal delay.
- 8) The Institute will not be responsible for collection of any of the above-mentioned documents.
- 9) In case, the application along with the requisite documents is not received within the stipulated time, it would be presumed that the parent organization is not in favour of appointment of the applicant on deputation.

Duly attested photocopies of their up-to-date Confidential Reports (at least for the latest 05 years) may also be enclosed with the applications. It may also be clearly stated that no vigilance/disciplinary proceedings are pending or contemplated against the candidates concerned. Applications without NOC, Vigilance Clearance and CR/ APAR Dossiers will not be considered.
